True Indicating's VH₂O₂ Ink, Product Code IPBP-01, is a flexographic ink formulation used to monitor exposure VH₂O₂ conditions. The ink is a water based formula which contains no heavy metals or other harmful materials and has low VOC's.

Intended Use

Indicator Ink is intended for manufacture VH₂O₂ Process and Multi-Critical Variable Indicators. The Indicators are intended for use in distinguishing processed from unprocessed goods or to indicate exposure to a sterilization process at a stated value (SV). Validation of Indicators and their performance is at the discretion of the manufacturer. The Indicator Ink has been confirmed to be ISO 11140-1:2014 Type 1 compliant on Tyvek® or Film when exposed per the conditions outlined below.



Instructions for Use

IPBP-01 is intended for flexographic printing onto Tyvek® or film based substrates. VH_2O_2 exposure of printed ink will transition from Blue to Pink. The shade of initial and signal color will depend on the thickness of ink printed, the substrate onto which it is printed, and the exposure conditions.

Colors shown are examples of actual printed ink using a 165 lpi Anilox roller and Tyvek®. Signal or end point color will vary due to printing conditions and exposure variables.

Storage and Shelf Life	
Shelf Life	4 months from date of manufacture
	15°C to 30°C (Protect from heat sources)
	Keep away from sterilant and other chemical agents. Do not reuse ink! Discard all remaining ink. Up to 5% by weight of water or ether can be added to the ink to decrease dry time.
	20% to 80% Relative Humidity

Disposal
